## Respective responsibilities of the body and the auditor

This smaller authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The smaller authority prepares an annual return in accordance with proper practices which:

- summarises the accounting records for the year ended 31 March 2016; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review the annual return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

## External auditor's report

On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

- A. The Council relies on the work of internal audit to inform its preparation of the Annual Governance Statement at Section 1 of the Annual Return. For 2015/16 the date of the internal audit report was after the date the Council approved Section 1. In future the Council should seek to obtain the internal audit report before it approves the Annual Governance Statement.
- B. We were required to return the Annual Return to enable the Council to correct an error in Section 2. The precept at Box 2 and council tax support grant (CTSG) included correctly as another receipt at Box 3 did not initially agree with third party evidence because an incorrect value for CTSG had been transferred from Box 2 to Box 3. In future the Council needs to ensure that the Annual Return is accurate before submission.
- C. In section 1, the Clerk and the Chair certified the Annual Governance Statement almost three weeks after the Council's approval. In future they should sign no later than the Council approval date.
